### Appointment of Yannis Natsis as Director of ESIP

The European Social Insurance Platform (ESIP), representing statutory social security institutions from 17 Member States and Switzerland, is delighted to announce that Mr Yannis Natsis has been appointed as Director of ESIP starting from 8 February 2022. He will take over this position from Dr Christine Dawson who is retiring after 20 years of successful work and advocacy on behalf of ESIP in Brussels.

Yannis brings to ESIP 10 years of experience in EU advocacy and policymaking. Prior to joining ESIP, he led the advocacy for better and affordable medicines at the European Public Health Alliance (EPHA). In May 2019, he was appointed by EU Member States to the Management Board of the European Medicines Agency, until December 2021. Yannis previously worked for the TransAtlantic Consumer Dialogue (TACD) focusing on health and pharmaceutical policies. He was an investigative reporter for Greece's award-winning TV news programme "Fakeli". He holds a Master's degree in International Conflict Analysis from the University of Kent, UK and a Bachelor's degree in European Studies from Panton University of Social and Political Sciences, Greece. Yannis is also a Board member of the European Health Forum Gastein (EHFG).
